Sir,

This refers to your online proposal No. IA/MH/IND2/27937/2015 dated 21st March, 2018 on the above subject matter.

- 2. The Ministry had earlier granted environmental clearance vide letter dated 20th March, 2017 to the project for expansion of Sugar unit (4500 TCD to 12000 TCD), Cogeneration Power Plant (20 MW to 70 MW) and Distillery Unit (60 KLPD to 160 KLPD) by M/s Baramati Agro Ltd at Village Shetphalgade, Tehsil Indapur, District Pune (Maharashtra).
- 3. The project proponent has now requested for amendment in the said environmental clearance for increase in number of working days from 270 to 330, spent wash treatment and disposal through bio-composting (for 60 KLPD), and installation of 32 TPH boiler for 100 KLPD distillery unit, in order to achieve Zero Liquid Discharge.
- **4.** The proposal was considered by the Expert Appraisal Committee (Industry-2) in its meeting held on 25 27 July, 2018. The Committee, after deliberations, has recommended for amendment in the environmental clearance dated 20th March 2017 as under:
- (i) The number of working/operating days for the proposed 100 KLPD distillery shall be 330 days in place of 270 days.
- (ii) New incineration boiler of 32 TPH capacity shall be installed for the end treatment of concentrated spent wash from the 100 KLPD distillery.
- **5.** Based on recommendations of the EAC, the Ministry of Environment, Forest and Climate Change hereby accords approval to the amendment in the environmental clearance dated 20th March 2017, **as stated in para 4 above**, with all other terms and conditions stipulated therein remain unchanged.
- **6**. This issues with approval of the competent authority.
